
## Recap of Club's May 18th Sea Bass Trip on the Bingo

### Orcas are attacking boats

In the past 5 years, orcas have been ramming, and in some cases, sinking expensive yachts, fishing boats, motorboats off the coast of Spain, Portugal, France and Morocco. This is not a rare occurrence since **more than** 673 boats have been attacked since 2020!

An international group of experts met in February and released a report why this is happening and what can be done to stop it. The report indicated that it is being done by **bored teenage orcas** looking for something to do. The orcas interact with vessels to be enriched by this experience. Overall, the incidents have mostly involved juveniles who are more playful in approaching boats and usually target the boat's rudders and have been seen playing with pieces of the rudders.

This international group discussed methods to deter orcas from ramming boats. Since orcas hate jellyfish, boaters are encouraged to add flowing pieces of jellyfish behind their rudders to ward off orcas from hitting them. Using jellyfish seems to be effective since ramming incidents have been decreased.

Why orcas, (are not actually killer whales but are the largest member of the dolphin family) are ramming boats because they are bored is just a theory. More research is needed to determine why this is happening.

# Giant Windmills Crumple to the Ground By John Toth

A tornado on May 14th hit southwest Iowa and brought down three windmills that were in a string of them with a height of 250 feet. They were knocked to the ground and engulfed in flames.

Wind turbine towers are now built to withstand events like tornadoes, hurricanes and typhoons because of advances in technology since the early designs of the 1990's. They have built in mechanisms to lock and feather the blades and changing their angles when winds reach 55 miles per hour. This reduces the surface area of the blades pointed toward the wind.

In Iowa, they think windmills are giants since they are 250 feet high. The windmills planned for off our coastline are 850 feet high! That is half the size of the Freedom Tower in lower Manhattan and they can be classified as Giants!

At 850 feet high, think of the surface area that would be exposed to hurricanes that would come up our coast and many are predicted for this year. What if we experience another storm like Sandy?

If a tornado can bring down a 250-foot windmill in Iowa that is designed so that does not happen, can 850-foot windmills stand up when similar storms batter our shoreline? I shudder to think of the environmental and navigational damage if these huge windmills are brought down by storms in our ocean for years to come. (New York Times, May 21, 2024)


### A 200 Lb. Alligator Snapping Turtle Caught

A Kentucky angler, Art Weston, a holder of several world fishing records, caught a **200 Lb. plus** prehistoric looking Alligator Snapping Turtle in Sam Rayburn Lake in Texas. He hooked it in its claw and had to be very careful removing the hook since the turtle could easily snap off all of his fingers. Catching this huge turtle gave him another world record with the International Fishing Game Association (IGFA). This turtle was safely released to enjoy open waters again.

Last year, he caught a **293 Lb. alligator** in the same lake on **the 6 lb. fishing line** that took him 1 hour and 30 minutes to bring it in. He received another world record from the IGFA for the tackle he used to catch this huge alligator. Source: Fox News, May 4<sup>th</sup>

## 2024 BIG FISH OF THE YEAR DERBY Rules

- 1. Fish have to be in season to be entered.
- 2. The fish can be caught anywhere, not in just New Jersey's waters.
- 3. The fish entered has to be verified by the boat captain or another club member or at an official weigh station. A picture of the fish is a much-preferred way to verify an entry into the Big Fish contest done by a cell phone or a regular camera. A club member can win more than one Big Fish contest prize.
- 4. Affidavits must be received within 30 days after the fish is caught. Entries for fish caught after 12/15 of a given year must be received by Janaury 15th of the following year.
