How Excessive Noise Can Hurt Whales and our Fisheries

I have written a number of articles about windmills and the threat they impose to whales and our fisheries. The list of these issues can be found on our club's website under the Environmental 1 ink. However, one if not the most important windmill issue, is about noise! There was an article in the Asbury Park's Press June 25th edition that sheds more insight on this important issue and I want to point them out to you:

In June 2013, researchers funded by the U.S. Navy discovered that the mid-frequency sonar sounds caused blue whales off the coast of California to change their diving behavior and temporarily avoid feeding areas.

In 2020, sonar used by Navy ships during a training session in the Bahamas lead to the death of six whales, while other whales that were stranded were pushed back out to sea according to reports at that time. Later necropsy reports released on their strandings revealed that the dead whales had hemorrhaging near the ears, according to the Journal of Science. An investigation revealed that the Navy sonar exercise nearby was most likely cause of their death.

The federal Marine Mammal Protection Act makes disturbing marine mammals like whale's illegal, but allows limited, permitted exemptions called "takes" under specific circumstances. Those exemptions include military operations, commercial fishing, oil and gas exploration and seismic testing.

NOAA Fisheries has granted New Jersey offshore wind companies' exemptions to the Marine Mammal Protection Act through what is called "incidental take authorizations," in order for companies to complete their turbine projects.

Windmills off our shores will be about 850 feet high with blades several hundred feet long that will make swishing sounds as they rotate. Anchoring these huge windmills will not be noise free and this noise will continue as long as the blades spin. Also, these windmills will make vibrating noise as the blades spin and this noise is not the type of noise that whales and our fisheries like to hear.

While we are rushing ahead to industrialize our ocean, this noise issue and others have not received the environmental review that they should have to ensure that whales and our fisheries deserve the protection they need from excessive noise. From my perspective, the federal government wants to put the windmills up fast and then see what happens next like rolling the dice- that may come up snake eyes!

We originally had a charter on this boat for a May 27th trip for fluke, but it had to be cancelled because of a mechanical issue resulting in delays for Bingo getting back into the water again while waiting for parts due to supply chain problems.

With the Bingo back in the water, Trip Captain Ralph DeJulia quickly put together a new charter trip for our club on August 19th. We had 18 anglers on board and there was a lot of action with everybody catching fish. It was a very windy day with at least 20 MPH or even more at some times. Even with that wind, this boat sat well in the water and the captain was very attentive to how well we were doing and moved quickly when the action dropped off. We enjoyed this trip on the Bingo and we booked two more trips on it for sea bass and blackfish October 21st & December 2nd respectively.

Update on Striped Bass Emergency Action Plan & Other Management Issues By John Toth

While we have great striped bass fishing in our area, other coastal states do not, especially in the Chesapeake area. This issue was taken up by the Atlantic States Fisheries Commission (ASMFC) and 14 states voted to approve the Emergency Action Plan to limit the new size of striped bass to 28 to 31 inches. Only New Jersey, a member of the ASMFC, voted against this new regulation. All states had to comply with this new striped bass regulation by July 2nd. This new regulation for striped bass will be in effect until October 28th - 1 striped bass from 28 to 31 inches. What happens after October 28th is still undecided. Most likely, it will be extended to the end of this year.

With this new regulation, we will be killing more striped bass that we can keep while trying to catch a legal bass within that 28 to 31inch restriction. While many of us I think, are opposed to this new regulation, other anglers are strongly for it since they are in "the only" catch and release crowd. They are the anglers who will catch many striped bass, 40 or so, and will think they are saving bass by throwing them all back when in fact a number of them will die by stress or by the mishandling them.

Also, this new regulation may have a negative impact on the party/charter boat industry since some anglers may choose not to go fishing for striped bass given this restriction on size. Less anglers fishing for striped bass means less tackle being bought at tackle shops.

In short, this new regulation for striped bass will make a lot of us unhappy.

Fluke - I am hearing we will have a cutback in our quota for fluke in 2024. This is **not certain** at this point, but we will have to see how this all unfolds in the near future. If it does happen, most likely the days we can fish for fluke in September will be reduced.

Sea Bass- In regard to sea bass, I also hear that our quota for them will not be changed for 2024 and remain the same as this year. We always seem to get cutback in our quota for sea bass even though there are plenty of them around. Fishing managers admit that that sea bass are not overfished, but will not increase our quota to catch them.

As I learn more about these issues, especially for striped bass, I will keep you updated on their status.

New Jersey Herring Fishermen's Case Could Shift Power

Decision may impact how federal agencies make rules

Several NJ Commercial herring fisherman say they don't think it's fair that a federal rule forces them to pay over 20% of their earnings to cover the salary of the government's at-sea monitors who ride on their boats. Their case is now going before the U.S. Supreme Court and it has a chance of upending the way federal laws are made so that these fishermen do not have to pay for the monitors imposed on them by the federal government.

The at-sea monitors collect scientific, management and regulatory compliance and economic data and report back to the government. They also focus on the discarded fish catch, or fish thrown back because they are not the target species or are undersized. This data is used for the management and monitoring of the annual catch limits.

The fishermen concede federal law allows the government to require at-sea monitors on their boats, but they argue Congress never gave the executive branch further authority to pass monitoring costs to the herring fishermen. They contend that the National Oceanic and Atmospheric Administration (NOAA), which manages the nation's fisheries, have abused its power. NOAA expects these herring fishermen to pay for these monitors as much as \$700 per day, in some cases, making them the highest paid person on the boat!

Their case looks to overturn a long-standing precedent set in a 1984 Chevron USA Inc., vs. Natural Defense Council Inc., which allowed NOAA to pass on these monitoring costs to fishermen. However, lawyers representing the fishermen contend that this case was legally flawed and did not give NOAA the right to pass on monitoring costs to fishermen.

A decision favoring the fishing businesses would have far reaching consequences since for 40 years people from all walks of life have been denied a fair hearing in federal court due to the Chevron case that put tremendous power in the hands of unelected bureaucrats.

The Supreme Court is expected to hear the herring fishermen's case in November.

2023 BIG FISH OF THE YEAR DERBY Rules

- 1. Fish have to be in season to be entered.
- 2. The fish can be caught anywhere, not in just New Jersey's waters.
- 3. The fish entered has to be verified by the boat captain or another club member or at an official weigh station. A picture of the fish is a much-preferred way to verify an entry into the Big Fish contest done by a cell phone or a regular camera. A club member can win more than one Big Fish contest prize.
- 4. Affidavits must be received within 30 days after the fish is caught. Entries for fish caught after 12/15 of a given year must be received by Janaury15th of the following year.
