# Status Quo for striped bass fishing during 2026 by John Toth

There has been a lot of discussion about closing the season for striped bass during two months of 2026 since the stocks are not up to where they should be. The Atlantic States Marine Fisheries Commission (ASMFC) and the Mid-Atlantic Marine Fisheries Council discussed this issue at their meeting on October 29th in Dewey, Delaware and voted for Status Quo-meaning no closures of striped bass seasons during 2026. This decision by these counsels is good news for the party/charter boat industry and tackle shops that depend on the business generated by anglers fishing for striped bass.

As I learn more about this developing issue, I will give it more coverage in our next club newsletter.

#### **Diver Spears Record Winter Flounder**

Jared Smith went diving on July 21st with the intention of spearing some fluke and lobster. He dove 125 feet to a wreck, R.P. Resorwreck, a 435 - foot oil tanker sunk by a German submarine during WWII. He saw a patch of big winter flounder by the tanker and shot a dart in to a snowshoe that turned out to be **3.82 lbs.!** 

He had it officially weighed at two locations and submitted it to NJ's DEP. It is now recognized as NJ's new state record in the diving category, beating the previous record holder by 1.2 ounces set in 2018.

## New Rule for our Big Fish of the Year Derby

Currently, entries for the Big Fish of the Year Derby allows for fish caught anywhere, not just New Jersey, to be entered into this Derby. A number of members who fish mostly in the local New Jersey/New York waters find this to be unfair since a lot of the big fish entered into the Derby are caught in other states that have better fishing opportunities. In reviewing this issue, our Board at its October 14th meeting voted to restrict entries into the Big Fish Derby to fish only caught in New Jersey/ New York waters and that will be **in effect during 2026.** At the end of 2026, the Board will review this rule again to determine if it still makes sense to continue this rule and make revisions to it if deemed necessary.

# Captain Ralph Leyrer of Last Lady retires By John Toth



# 2025 BIG FISH OF THE YEAR DERBY Rules

- 1. Fish have to be in season to be entered.
- 2. The fish can be caught anywhere, not in just New Jersey's waters.
- 3. The fish entered has to be verified by the boat captain or another club member or at an official weigh station. A picture of the fish is a much-preferred way to verify an entry into the Big Fish contest done by a cell phone or a regular camera. A club member can win more than one Big Fish contest prize.
- 4. Affidavits must be received within 30 days after the fish is caught. Entries for fish caught after 12/15 of a given year must be received by Janaury 15th of the following year.
