Enjoy a Wild Game Dinner



Letter to NJ DEP Concerning Access Restriction to Tidal Waters for Endangered Species Protection By John Toth

When endangered birds like the Piping Plover arrive at our NJ beaches, the area where they nest is closed by fencing to protect them while they are in the process of laying their chicks and beach access by this area is also restricted for their protection. While we want to protect endangered species by our beaches, the New Jersey DEP has proposed a new regulation: Access Restriction of Tidal Waters for Endangered Species Protection (N.J.A.C.7-25-4 A.3) and this regulation will impose restrictions on public access to beaches and our use of them.

Under this new regulation, areas where endangered birds used to nest will be closed even when the birds are not even there. Beach access by these areas will be restricted and also the location where the birds are expected to nest. This is an overreach by the DEP and imposes restrictions on the public using the beach for a variety of uses such as walking, fishing and other recreational activities. Additionally, some local municipalities who do everything they can to restrict access to anglers may use this DEP proposal to further restrict access to their beaches for anglers on the pretext of protecting the birds.

A number of recreational fishing clubs are concerned about this NJ DEP proposal and are in the process of developing a letter outlining their concerns about this proposal that is being drafted by a Mr. George Browne who has been a very vocal advocate to protect beach access for the public. I personally know George since I was in Trenton working with George and other groups to develop guidelines on beach access guidelines for the Public Trust Document. George has asked fishing clubs and other associations to sign on to his draft letter as a show of support. I brought this issue up at our club's January 14th Board meeting and our Board approved our club signing on to this letter. Other clubs have already signed up to this letter, including our friends at the Hudson River Fishermen's Association (HRFA).

Comments on the NJ DEP proposal are due February 13th and this letter will be sent to them by their deadline. I will keep you updated on this issue as it unfolds.

Flounder is a Unique Fish By John Toth

Around 66 million years ago, a six-mile asteroid slammed into earth and turned the sky black wiping out over half of the species on land and earth. This mass extinction opened up ecological opportunities for the survivors. One survivor lineage split apart, with some individuals finding opportunities in the open ocean and others settling on the sea floor. Flounder, like 800 hundred species of flatfish, lie flat on the sea floor, their two eyes gazing up at the water overhead. When a smaller fish swims by, the flounder shoots up and strikes.

The larvae of flounder look normal with eyes on both sides of their head. Only when they go through metamorphosis into adults does one eye migrate to the other side of the head. Hormones from the thyroid gland trigger larvae to go through this metamorphosis. The hormones switch on genes in the flatfish skull that cause it to take shape, helping to push one eye into a new position. Inside the eye itself, other genes simulate the growth of the neurons so that it can stay connected to the brain as it travels into a new place. This movement of an eye to another side of a flatfish is one of nature's mysteries.

In Darwin's "Origins of Species, he argued that natural selection favors tiny variations. Each little increment benefited an organism. Over countless generations he said that those increments gradually added up to large-scale transformations. One critic of Darwin's theory, (George Jackson Mivart, a British biologist) rejected such changes could possibly happen. It seemed impossible to him that the slow migration of the eye around the fish's head would be advantages at every stage of the way. "How such transit of one eye a minute fraction of the journey toward the other side of the head could benefit the fish is unclear." Of course, Darwin was right and nature has the final say on how flounder should look like with two eyes on one side of its head.

I watched a video on how a flounder camouflages itself by using its tail to flip sand over its body so that it is totally covered with only its two eyes sticking up. It also seems to change its color so that it matches its surroundings, making it practically invisible to its prey. It is a very unusual fish compared to others, but unusual or not, it is one of the fish that many of us enjoy to catch and especially to eat!

Seasonal Striped Bass Closures May Happen in 2026By John Toth

Toward the end of 2024, the Atlantic States Marine Fisheries Commission (ASMFC) was considering closing the months we could fish for striped bass in 2025. This could be the months of November and December of 2025. The ASMFC's justification to do this was that the biomass of striped bass was too low at only at 191 pounds and striped bass stocks were in trouble because we caught too many of them. The ASMFC wants the biomass of striped bass to be increased to 247 million pounds by 2029. One of the ways to do this is to close the seasons we could fish for them. The ASMFC decided on December 16th not to do any seasonal closures for 2025 and the regulations we have had in 2024 for striped bass will remain the same for 2025, 28 to 31 inches, including the Bonus Tag program. However, the ASMFC Board also voted to initiate a new Addendum which is to be completed by October 2025 that will list a number of options, including seasonal closures, to reach the new target of 247 million pounds of striped bass. This Addendum will allow for public comment on these options. After hearing public comments, the ASMFC will make their final decision on which option to approve at their January 2026 meeting. All states will be required to implement this option for their striped bass season during 2026.

According to their own data, the ASMFC projects that there is only a 50% chance of reaching their 247 million pound target with the seasonal restrictions for striped bass that may be imposed upon the recreational community. If there is an inability for us to reach this goal, then why have such a high target of 247 million pounds for striped bass that we most likely will not reach? This does not make sense to me and I do not believe that I am alone in this conclusion.

If there is a closure of a month or especially two that we can fish for striped bass, it would be devastating to the for-hire industry! A captain told me that he would lose at least 25% of his striped bass charter trips. Tackle shops and marinas would also be adversely affected by this seasonal closure. The ASMFC is relying on data to justify their restrictions for striped bass that we have seen time again to be unreliable. I still remember that during Sandy when so many boats were destroyed, we were told that we overfished our fluke quota!

It seems to me that we are always being punished by the ASMFC and other fishing managers by having our quotas reduced and now we may have seasonal closures for striped bass. For example, the stocks of black sea bass are up over 200%, yet we almost faced a reduction of our black sea bass quota by 20% for our 2025 season by fishing managers. By the way, I still remember a number of years ago I was at a meeting in Philadelphia initiated by fishing managers to consider closing the fluke for a month or possibly two just like we are facing with striped bass. It did not happen because of our opposition to this proposal.

While we are facing so many restrictions on our ability to enjoy fishing, so many fishing boats have gone out of business. Bob Bogan, Captain of the Gambler, wrote a report in 2002 that showed 50 fishing boats have gone out of business because of punitive regulations imposed by the ASMFC, the National Marine Fisheries Service and the Mid-Atlantic Marine Fisheries Council. This report did not cover the tackle shops and marinas that also lost their businesses. It is always reducing the quota of a certain fish or reducing the bag limit of that fish. Maybe one day we will finally see a decision by fishing management that finally works in favor of us!

I will keep you updated as this striped bass issue.
