Also, check the rules to enter your fish in our Big Fish Derby contest.



#### With Empire Wind Getting the Green Light – the Trouble Begins Now By John Toth

Empire Offshore Wind LLC, a project between Norway- based Equinor and oil and gas company BP, received permission from the Bureau of Energy Management (BOEM) during the Biden Administration to build an Offshore Wind Farm 19.4 miles east of Long Branch, NJ. On April 16th, the Trump administration put a temporary stop to this project on the grounds that it was not properly reviewed for its environmental impacts on habitat and marine life. On May 4th, the Trump administration lifted its stop-work order on this off shore wind project. Once a project like Empire Wind receives approval from BOEM and the previous administration, it is very difficult to stop this work in progress since it has been deemed to be fit to move forward.

For many of us who have fought offshore wind projects like Empire Wind, we were stunned by this bad news! We fear the negative environmental impact that it will have on our ocean and especially its marine life. Empire Wind will be in the process of dumping thousands of tons of rocks into the ocean by the New York Bight area to prepare for the construction of huge monopoles, the foundations upon which the 54 giant windmills will sit. These rocks- 32 billion pounds will destroy habitat by burying vital sand shoals that serve as nursery grounds for species like fluke, squid and scallops. If that is not bad enough, Empire will also start pile-driving the massive 180-foot monopoles into the sea floor. Tons of rocks will cover sand shoals that fish need and the tremendous underwater noise and vibrations will harm all marine life. especially endangered right whales

Already on the edge of extinction, these whales will migrate directly through Empire's construction zone. This noise will affect the navigation and communication abilities of these whales as well as fin and other whales. These whales may even experience temporary deafness.

On top of that, the New York Bight area is one of the busiest maritime zones along the East Coast with many huge container ships passing through it. Placing 54 huge windmills near it risks a major catastrophe especially in poor weather conditions. Offshore wind farms can interfere with navigational radar used by ships to avoid collisions, posing challenges for safe maritime navigation, a 2022 report released by the National Academy of Sciences, Engineering and Medicine found. Shutting down shipping activity in the New York Bight due to collisions would have grave economic consequences, especially for the container shipping industry and the jobs that depend upon it. Also, under the terms of its permit, Empire Wind must shut down operations whenever ordered to do so by the Department of Defense and the FAA has warned that the turbines, 850 feet high, could interfere with radar at JFK, Islip and Westchester Airports.

Empire Wind is expected to provide power to 500,000 New York homes, but at what cost? Offshore wind is four times more expensive than New York's average wholesale electricity price. Nor is it reliable needing 24/7 backup from fossil fuel when the wind is not blowing enough to move the blades. Offshore windmills require billions of dollars in new transmission lines to bring electricity ashore adding to its price. While households will pay more for electricity use, any profits will go to the Norwegian-based company of Empire Wind.

President Trump bans or restricts new offshore wind farms in federal waters, but does not explicitly halt projects already approved with federal leases and permits as in the case of Empire Wind.

Unfortunately, unless some miracle happens to slow or stop Empire Wind, I see this destructive project moving forward.

#### Some Facts about the North American Right Whale

The American Right Whale is the most endangered species of whales in the world. There are estimates of only about 400 -350 of them left.

They can grow up to 50 feet and weigh 60 tons. At birth, they can be as long as 15 feet and weigh 2,000 pounds.

They are slow-moving at 3 to 7 miles per hour, making them vulnerable to boat strikes. In the USA, all boats are required to stay at least 500 yards away from them.

# 2025 BIG FISH OF THE YEAR DERBY Rules

- 1. Fish have to be in season to be entered.
- 2. The fish can be caught anywhere, not in just New Jersey's waters.
- 3. The fish entered has to be verified by the boat captain or another club member or at an official weigh station. A picture of the fish is a muchpreferred way to verify an entry into the Big Fish contest done by a cell phone or a regular camera. A club member can win more than one Big Fish contest prize.
- Affidavits must be received within 30 days after the fish is caught. Entries for fish caught after 12/15 of a given year must be received by Janaury15th of the following year.



#### Working at Sea for 8 Years without stepping on land

North Korea's leader Kim Jong-un established a new source of revenue for his cash-strapped regime by sending out 40,000 of his people to work abroad in restaurants in China, logging camps in Russia, construction sites in the Middle East and on Chinese fishing boats. Most of the salaries of these workers are sent to Kim Jong's regime with a very small amount given to them by their ruler.

Until now, the fate of North Korean fishermen has dawn little global attention because they were in vast oceans and cut off from the rest of the world and even their own families did not know where they were. These North Koreans were assigned to work on Chinese long line tuna boats working mostly in the Indian Ocean. Before these ships docked, North Korean fishermen were transferred to nearby sister ships and then moved back again when these ships went out to fish again. If their presence was discovered by port authorities, it would create legal trouble for Chinese captains. The passports of the North Korean fishermen have been seized by their government to have better control of them and their ability to escape.

The plight of these North Koreans was reported to authorities by Indonesian fishermen working on the same boat as the Koreans. They reported that the Koreans have worked up to eight years without being on land and one of them said that he has not contacted his wife during this entire time period. The Koreans are not allowed to have phones. Given these conditions, their families do not know if their loved ones are alive or dead.

In 2017, the UN Security Council adopted a resolution requiring UN member countries to expel North Korean workers by the end of 2019. But more than 100,000 North Koreans were still working in 40 countries according to a UN panel of experts. For more than three decades, North Korea has sent workers abroad earning billions of dollars according to South Korean estimates.

North Koreans are also required to spy on each other when they go abroad and maintain a life of indoctrination.

About 11,000 North Korean soldiers have been sent to Ukraine to fight for the Russians. A number of them have been captured by Ukrainians and interrogated, the North Korean soldiers indicated that they were not told by their government why they were sent to Ukraine to fight for Russia.

#### **Death by Octopus**

A South Korean man has died of a heart attack after choking on a "Live Octopus"

- year old man could not be revived after he choked on a dish known as San-Nakji and suffered cardiac arrest. He was pronounced dead at a local hospital.

Still-squirming octopus seasoned with salt and sesame oil is among the nation's most notorious delicacies.

Many videos have been posted on You Tube showing thrill-seeking tourists trying San-Nakji in Korean fish markets. Some have died of heart attacks. San-Nakji has been described as among the **world's most dangerous foods**.

San-Nakji translates to "live octopus", but the octopus is killed before serving with its tentacles cut into dish with wriggling tentacles that was served as a local delicacy.
